

Lasarotta COVID-19 Terms and Conditions

1. **Lasarotta** require full payment for all special deals and all arrangements taking place earlier than 180 days from booking but in the case of COVID-19 pandemic will do exceptional change of its terms and conditions.
2. In all other cases we will need deposit (50% of total cost) to confirm your booking but during COVID-19 - 19 we will split this amount as 20% nonrefundable but deposit transferable for 2022 if not possible to travel by 01 June 2021. Different dates will be given in that case for 2022 without extra charge. 30% is due 2 months before arrival once flights are confirmed in June 2021 or at earlier stage.
3. Other 50% are due 180 days prior to your visit in normal circumstances but during COVID-19 pandemic we will do cash payment at the first night of arrival but before start if shooting. This way both sides take reasonable risk of cancellation that if it happens 2 months before arrival, we will hit be able to refund 50% already paid and it will have to be insured with other cancellation policy if there is obstruction caused by pandemic Covid-19 or similar during that time we would be able to rebook dates for the 2022 but clients would lose 30% of original bookings with 80% being sorted 2 months before arrival in 2020.
4. If the client cancels the hunting and we can re- let the booking, a refund of 60% will be made. If due to the lateness of the cancellation when re-letting is not an option, the client is liable for the full cost.
5. The difference between prepaid arrangements and other services will be paid in cash or Visa card after the hunting in the relevant hunting grounds, unless otherwise agreed prior to hunting. The invoice for local services will be issued in the national currency (e.g., Serbian national currency is Serbian Dinar).
6. To all the local cash bills receipt with local VAT will be applied provided with our local partners as late bar bills, cartridges or sporting arms hire.
7. Trophies will be provided with a trophy certificate. Trophy charges for deer are calculated by weighting the whole trophy without the lower jaw within 24 hours after the game has been shot. Other species trophies may occur because of their actions. The minimum amount of cover should be no less than £2,000,000.00 for any one claim.
10. All instructions and decisions given by stalkers and keepers are final. Failure to comply with such instructions or decisions may result in the cancellation of the booking with no right to a refund or compensation.
11. All sportsmen will be required to hold a valid appropriate license for the legal use of sporting weapons.
12. All hunters will be required to make 2 successful test shots at a target. If the hunter misses, he/she will be unable to hunt until he/she has satisfactorily hit the target.
13. **Lasarotta** reserves the right to cancel any hunting with a full refund given for all sporting costs.
14. All warranties (expressed or implied) are disclaimed, but not limited to implied warranties of merchantability, fitness for a particular purpose, and non-infringed. **Lasarotta Ltd.** functions as a marketing agent in the UK for several different principals (hunting grounds from Slovenia, Croatia, Bulgaria, Serbia, Macedonia, Bosnia, and Montenegro) and cannot be responsible for any possible negligent behavior that can cause accident. Shooting is highly dangerous sport and even if implemented safety regulations and insurances attempt to cover all possible unpleasant accidents, **Lasarotta** do not accept corporate responsibility for any injury or death or any accident that can happen on any shooting ground that we promote.
